Fiscal year 2023 began with its largest exhibition of the year, *Towers of Tomorrow with LEGO® Bricks*, which had opened in May 2022, and went on to include a great year for ArtSplash and a diverse schedule of exhibitions, programs, and classes. The exhibitions in particular represent a heightened level of depth and seriousness.



Local Perspectives

The fiscal year began with summer art camp, great exhibitions of local and regional art, and ArtSplash. The summer camps were successful, with children attending one of five two-week camps in the Gilchrist Learning Center. In July, the Art Center opened its first exhibition of the fiscal year, *Local Perspectives*, which featured art produced by dozens of artists within a 50-mile radius of Sioux City. This exhibition was followed in August by a dynamic exhibition of art by Nancy Friedemann-Sanchez of Lincoln, Nebraska, whose enormous, collaged artworks, inspired by her childhood in Colombia, transformed the Main Gallery. Over Labor Day weekend, ArtSplash returned to the Art Center buildings and grounds and to the surrounding streets. More than 15,000 visitors were counted during the two days.

Johns then took black-and-white photographs of the speakers. The exhibition featured large prints of the photographs, brief transcriptions of the interviews, and QR codes that allowed visitors to listen to the speakers tell their full stories. The spring concluded with *The Briar Cliff Review Exhibition*, the final exhibition in a long-running partnership with Briar Cliff University.

Spring 2023 also featured a spectacular two-day special event and fundraiser, which took place in a fully transformed Art Center atrium. “Through the Looking Glass” was a fanciful evening for adults with creative cocktails, interactive experiences, and a performance by actors at Lamb Theatre that brought the audience to their feet. The next day, families came for lunch, tea, and activities at the Mad Hatter’s Tea Party.

For fiscal year 2024, the Art Center is working on a series of outstanding exhibitions of art by artists from Iowa, Nebraska, and Minnesota. With the leadership provided by the City of Sioux City in combination with the support of many individuals, businesses, and foundations, the Sioux City Art Center looks forward to continuing its service to Sioux City.

Sioux City Art Center Expenses



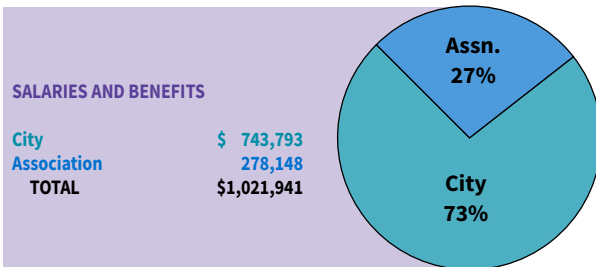

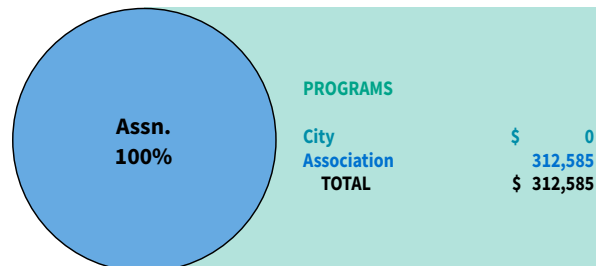

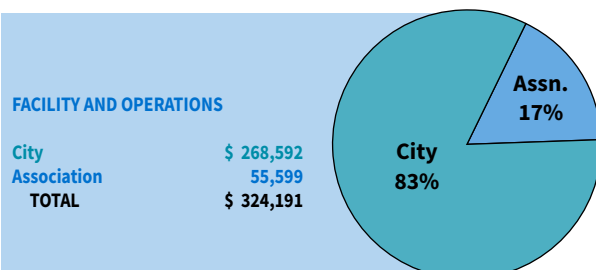

YOUTH ART MONTH

This was the Art Center's 34th year of collaboration with area schools to recognize and celebrate youth art education with a month-long juried exhibition of student artwork. The exhibition, from February 25 to April 9, 2023, featured 69 artworks from middle school students (6-8th grade). Three hundred fifty-six entries were submitted, of which juror Shelby Prindaville selected the 69 to be represented in the exhibition. An opening reception welcomed over 300 people on February 26 with Mayor Scott, Mayor Pro-Tem Moore, and Superintendent Earleywine attending as special guests to distribute student awards.

CLASSES AND WORKSHOPS

A total of 37 adult and children's classes and workshops were offered to the public throughout the year. 222 students participated in classes with a total of 1,728 accumulated contact hours. Fifty-five weekend family drop-in art classes were offered most Saturdays throughout the year with 529 total participants. Five six-day art camp sessions were offered with approximately 121 participating kids.

The Winter Holiday Workshop was held on December 3 with 16 workshops throughout the day and a total of 124 attendees. Finally, Spring Fling was held on Saturday, April 29, and welcomed 88 people in the morning. Children were able to select a craft to make from four spring-themed art activities.
